PRIVACY POLICY

The information we collect and how we handle that information differs depending on who you are and why we are collecting the information.

THE PERSONAL INFORMATION WE COLLECT AND USE RELATING TO OUR CLIENTS, THEIR PROFESSIONAL REPRESENTATIVE'S AND THOSE OF THE OPPOSING SIDE

MRLS will collect personal information from its clients, their professional representative's and those of the opposing side.

The information we collect

We may collect the following types of information:

- Name, address, email address, telephone number(s) and other contact details
- Your company's name, your position in the company, the company's address and your company email address and telephone number
- Information required to provide you with a service and details of our services that you have used (for example, valuations, lease extensions and collective enfranchisements)
- Details of any enquiry you have made to MRLS

- Improve and develop our services and performance as Chartered Surveyors
- Develop and provide products and services, either on our own or in conjunction with third parties (for example the provision of training courses with the RICS - Royal Institution of Chartered Surveyors or ARMA - the Association of Residential Managing Agents)
- Meet our regulatory obligations

We rely on legitimate interests as our lawful basis for processing the personal information relating to our clients, professional advisers and other side.

It is necessary for us to process the personal information we have described so that we can perform our role as a Chartered Surveyors. Our processing activities are a targeted and proportionate way of achieving this. Our clients, professional advisers and other side reasonably expect that we will process their personal information.

THE PERSONAL INFORMATION WE COLLECT AND USE RELATING TO THIRD PARTIES

MRLS will collect personal information from third parties, including members of the general public who contact us.

The information we collect

We may collect the following types of information:

TRANSFER OF YOUR INFORMATION OUT OF THE EEA

MRLS will not transfer your information outside the European Economic Area

YOUR RIGHTS

Under the [General Data Protection Regulation](#) you have a number of important rights free of charge.

In summary, those include rights to:

- fair processing of information and transparency over how we use your use personal information
- access to your personal information and to certain other supplementary information that this Privacy Notice is already designed to address

- require us to correct any mistakes in your information which we hold
- require the erasure of personal information concerning you in certain situations
- receive the personal information concerning you which you have provided to us, in a structured, commonly used and machine-readable format and have the right to transmit those data to a third party in certain situations
- object at any time to processing of personal information concerning you for direct marketing

- claim compensation for damages caused by our breach of any data protection laws
